Hospitality Rider

This performance rider will be agreed to by both parties and considered an addition to the contract attached for this performance to take place on _____ by and between VISHUDDHA, hereinafter referred to as "Artist" and _____, hereinafter referred to as "Purchaser".

Please initial next to each item on the rider to show purchaser's approval and compliance.

- Complimentary Tickets _____
If applicable, Purchaser agrees to provide Artist with a minimum of six (6) complimentary tickets and/or guest list names for admittance to the contracted event, excluding designated crew members of the Artist.
- Parking _____
Purchaser agrees to provide Artist with free parking (and or parking passes) that is close to the venue loading entrance suitable for a van or small bus with an attached trailer. Approximate clearance needed is 40 feet long.
- Food and beverages _____
Purchaser agrees to provide the following:
 1. At least one 12-pack of micro-brewed/imported beer—access to draft beer can be substituted in the absence of micro-brews or imports (preferred choices include Highland, Sierra Nevada, Bass, and Paulaner)
 2. At least two 12-packs of domestic beer—access to draft beer can be substituted in the absence of domestics (preferred choices include Yeungling, Busch, and Miller High Life)
 3. At least one 750 ml bottle of Bourbon, Canadian, or Scotch Whiskey (preferred choices include Jack Daniels, Crown Royal, Seagram's VO, or Jameson)
 4. At least twelve (12) bottles of non-carbonated spring water or sufficient clean, preferably filtered water from a bar tap
 5. At least 6 bottles of assorted fruit juices
 6. At least one 6-pack of Coca-Cola
 7. At least one (1) hot meal for each of the band and crew members (total of 5) with a vegetarian option (no beef and no pork), or the option for a Fifteen (15) dollar buyout per head.
- Dressing Room _____
Purchaser agrees to provide Artist with a clean, dry, and well-lit dressing room to change before, during and after the performance. In addition, Purchaser will provide a safe place for band members to store valuables during the performance and if necessary, will provide at least one (1) security person to be stationed at this assigned area to ensure the safety of the band's valuables.
- Hotel Rooms _____
Purchaser agrees to provide two (2) double rooms each with a fold out cot, at a clean hotel no more than twenty (20) miles from venue or room buyout to be worked out in advance with the Artist.
- Band and Crew _____
Purchaser agrees to provide five (5) full access passes for band and crew to fulfill their positions for the Artist.
